New Carilion Research Opt-out Process

Carilion is preparing for further advancement of the research enterprise. Current practice at Carilion requires that the treating providers be the first patient contact about potential research opportunities. We are changing practice so that patients can be contacted by researchers who are not their providers.

The first step is a new process to allow patients the choice to **opt-out** of being contacted by researchers who are not their providers. Patients will be notified by various methods, and their responses will be gathered. More information will be provided over the next several months as this significant research recruitment practice change is being developed.



Please note that the current recruitment process remains unchanged, and the IRB approved plan must be followed.
