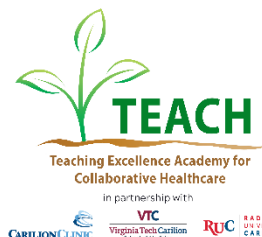


Hi there!

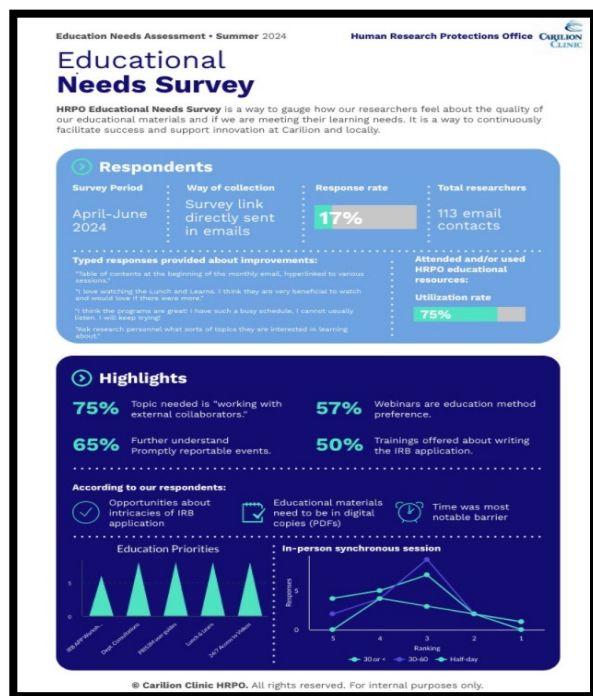
